# APPROXIMATELY 15 HA PROTECTED IN PERPETUITY IN THE LAKE MEMPHREMAGOG WATERSHED

Magog, March 20, 2025 - The Fondation Nature Memphrémagog (FNM) and the Memphrémagog Conservation (MCI) are proud to announce two new acquisitions for conservation purposes in the municipality of Ogden, close to 15 hectares in the vicinity of Lake Memphrémagog. This conservation success is the result of a unique partnership with key partners including the local community and Appalachian Corridor.

This new protected area adds to the 120 hectares already protected by the FNM. Several of these properties have been protected in partnership with MCI. This project is funded by Environment and Climate Change Canada through the Nature Conservancy of Canada's Community Designated Priority Sites for Species at Risk program.

#### Water quality and climate change: challenges to be met

This protected area located in the Lake Memphremagog watershed supports the quality of the lake's water, a major source of drinking water for the region. Forests, wetlands and riparian buffers provide several ecosystem functions, such as regulating water flow and filtering runoff.

These protected natural environments will help to combat climate change, thanks to their potential to capture carbon and mitigate the effects of extreme weather events such as heat waves and floods.

The protection of this new protected area shows that it is possible, both locally and in the Lake Memphremagog watershed, to contribute to global issues such as biodiversity loss and climate change.

# **Biodiversity protected forever!**

The creation of this new private protected area will preserve valuable natural environments in perpetuity, including forests, wetlands and waterways.

Many of the species inventoried in the area are at risk, such as the Wood Thrush and the Eastern Wood Pewee, two forest birds; the Bald Eagle, a diurnal bird of prey; several species of bats; and plant species such as the Northern Maidenhair Fern and Canada Wild Ginger.
