## 4. President's report

Mrs. Lavoie emphasizes the importance of MCI's actions for the protection and monitoring of Lake Memphremagog for present and future generations, since 1967.

'We better protect what we know'

Here are the files where we have invested a great deal of energy this year:

- **Actions in the field:** revegetation of riparian zones, control of invasive exotic species
- Meetings, collaboration, committees, conferences, training, etc. with various partners in environmental matters
- With federal and provincial deputies, municipal representatives, owners, various environmental organizations
- **Navigation** modification of federal regulations put in place thanks to the pressure exerted by MCI
- **Coventry**: Position paper and monitoring.
- Conservation plans for the Lake Memphremagog watershed and the City of Magog
- Development of **various tools to improve awareness** (conferences, pamphlets, web site, training, infoletters, etc.)
- Monitoring activity on the lake and shoreline

## 5. Membership report by Peter Lépine

Mr. Peter Lépine presents the annual membership report.

It should be noted that the number of memberships has decreased, but the amounts are higher than the previous year. (See Annex 1)

## 6. Presentation and approval of the financial statements as of March 31, 2024

In the absence of Mr. Olivier Barsalou-Provost, the financial results for the fiscal year ending March 31, 2024 (see Annex II) are presented by Mrs. Ariane Orjikh, General Manager.

Highlighted points:

- MCI is in good financial health.
- The boat is being paid off gradually.
- The COVID loan of \$40,000 has been repaid; an amount of \$20,000 remains in the bank.
- Distribution of funds used: 20% administration, 80% various projects.
- Salary increases for staff retention purposes, among others.
- Government grants: Federal \$14,000 / Provincial \$19,000.

## **7.** 2023-2024 activities report

Mrs. Ariane Orjikh, General Manager, presents the MCI work teams for the various projects and briefly explains the files. Mrs. Fanny DeBlois and Chanel Racine-Mineault, patrol coordinators and project managers, then present the report on the activities of the past year and those in progress.

## 8.1 The 2024 patrol is made up of a very experienced dynamic team:

- Fanny DeBlois, Bachelor's in ecology
- Chanel Racine-Mineault, bachelor's in ecology
- Claudie Ouellet, bachelor's student in environmental studies
- Émile Derbesy-Lanari, bachelor's in ecology
- Léa Locas, bachelor's student in ecology

## 8.MCI is involved in the following projects:

## a) Conservation plan for the Lake Memphremagog watershed

Federal and provincial subsidies:

- Priority areas for endangered species defined by local communities
- PPMN
- In collaboration with Appalachian Corridor (ACA) and the Nature Conservancy of Canada (NCC)

# b) Voluntary conservation: Protection of natural areas in the Fitch Bay watershed

- Working with owners of natural areas on the conservation of their property.
- Inventories of natural areas

## c) Coventry file 2023-2024

- Moratorium on the discharge of leachate in the watershed until January 1, 2028: Objective of applying the precautionary principle: no treated or untreated leachate should be discharged into the Lake Memphremagog watershed
- December 20, 2023: Submission of a brief by MCI on the proposed pilot project to treat the leachate on site.
- June 10, 2024: A meeting bringing together representatives of the political attachés of the federal Ministers Mrs. Bibeau and Mrs. St-Onge, of provincial MNA Mr. Bélanger and his political attaché, as well as a representative of the Memphremagog MRC

## d) Participation in committees and forums

MCI is also represented on committees of various organisations, round tables and boards of directors, **requiring approximately forty participations in 2023-2024**

The patrol will carry out several water quality monitoring activities in collaboration with the government of Québec, the Memphremagog MRC and the City of Magog.

## 8.4 Monitoring of protected natural areas

- The projected Michael Dunn biodiversity reserve in partnership with the Québec government since 2020
- Long island and Molson island in partnership with the Nature Conservancy of Canada since 2021

## 8.7 Buoys in eco sensitive zones

Buoys indicating ECO SENSITIVE ZONE have been installed at 5 locations on Lake Memphremagog to encourage users of the lake to be prudent in these areas.

Project subsidized by the regional support program for water issues (**PSREE**). Objective: Creating wider shoreline buffer zones in residential areas to improve the quality of Lake Memphremagog's water.



#### 1. GOVERNING STATUTES AND PURPOSE OF THE ORGANIZATION

The organization, incorporated under the Part III of the Compagnies Act (Quebec), aims to ensure the safeguard of the Lake Memphremagog environment and its watershed for future generations. The organization is registred has charitable organization under the Income Tax Act.

# 2. BASIC OF ACCOUNTING APPLIED IN THE PREPARATION OF THE FINANCIAL INFORMATION

The method of accounting applied in the preparation of the financial information is based on historical cost, taking into account cash operations as well as the following elements:
