1. Opening of the Annual general meeting

Mr. Robert Benoit welcomes the attendees to the 55th annual general meeting of MCI, and thanks the members for their presence at the annual general meeting.

To begin, Mr. Benoit notes the presence of Mrs. Vicki-May Hamm, ex mayor of Magog.

Mr. Benoit notes the status of MCI's accomplishments and commitments over the past year. All the objectives have been met.

Mr. Benoit thanks MCI's personnel, its board, its volunteers and the local universities and municipalities for their significant involvement.

4. President's report

Mr. Benoit notes MCI's accomplishments in various files, such as the position paper on the MRC Memphremagog's management plan, with 81 recommendations, the Coventry file and the 4 year moratorium, MCI's improved communications, the increasing presence of MCI in various groups and committees, the acquisition of a new motor for the boat, etc.

As well, Mr. Benoit congratulates and thanks the following people for their recent ecological donations:

- Molson Island Mr. Andrew Howick: Donation to the Nature Conservancy of Canada
- Property of 18.5 Hectares in Fitch Bay belonging to the Fluet family: Donation to the Fondation Marécages Memphrémagog

As part of the patrol's 50th anniversary, we note the presence of Mr. Graham Taylor, who was the first MCI patroller. On this occasion, a small reception will be held after the meeting, bringing together many former patrollers.

Mr. Benoit introduces Mr. Clément Brada, speaker on environmental issues. As well, a first bursary will be awarded this summer from the funds accumulated for this purpose.

5. Membership report by Peter Lépine

Mr. Peter Lépine presents the annual membership report. Donations have doubled over the past 10 years. An increase in memberships is noted.

6. Presentation and approval of the financial statements as of March 31, 2022

He underlines the excellent financial situation of the organization and the government support we received.

Strategic planning 2022-2026

MCI's 2022-2026 strategic plan has been prepared by a group of MCI board members. The plan contains 7 strategic choices:

- Continue to evolve our communications strategy;
- Increase and diversify our membership;
- Solicit financing in various ways, such as subsidies, sale of services and contributions from members and donors, from municipalities and governments;
- Maintain and increase partnerships with organisms, municipalities and governments who carry out projects related to the protection of Lake Memphremagog;
- Base our work on the acquisition of scientific knowkedge;
- Be present in the public space and at the forefront of the different issues affecting the environmental health of the lake;
- Educate the public as well as property owners of the importance of protecting the lake and its watershed.
- The two year, bi-national study of sport fishing on the lake is now complete. Thousands of interviews with anglers on the lake were carried out in all seasons, summer and winter. The report will be available mid July 2022.
- A new pamphlet on improving road maintenance practices, called My road, my lake, my responsibility!, financed by the Québec government, was produced and distributed in the Fitch Bay sector

- Last April, MCI shared its position paper on the first draft of the Memphremagog MRC's new Urban and Sustainable Development Plan with the municipalities within the watershed. This was a long and complex analysis and specific recommendations regarding the protection of the lake were included.
- MCI sits on various organizations' committees, regional oversight committees, and boards of directors, as follows:
 - Québec-Vermont committee
 - Coventry landfill oversight committee
 - The City of Magog's consultative environment committee
 - Working group for the regional wetlands plan (MRC)
 - COGESAF's local watershed committee
 - Regional round table on exotic invasive species
 - Eastern Townships committee on the zebra mussel

- RAPPEL's board of directors
- Memphremagog Watershed Association's board of directors
- DUMP's board of directors
- Decibel Coalition
- Grouping of the Austin lake associations

Mrs. Frédérique Thibault-Lessard, 2022 patrol coordinator and project manager presents the report on last year's patrol activities and those ongoing this year:

- The patrol continues its inventory of adult zebra mussels and gastropods using snorkels.
- Water quality sampling: the patrol carries out regular water sampling in collaboration with the Québec government, the Memphremagog MRC and the City of Magog.

The following parameters are analyzed:

- Chlorophyll a
- Dissolved organic carbon
- Total phosphorus
- New in 2020: cyanobacteria
- New in 2021: Station 246 every month.
- Again this summer, the patrollers worked cleaning up the Projected Michael Dunn Biodiversity Reserve after the its use by boaters. This summer, the patrollers will carry out an awareness campaign there and do regular clean up of the site, in partnership with the Québec government.
- Buoys showing ECOSENSITIVE ZONE have been installed at 5 locations on the lake to make boaters aware that they should approach these areas with caution.
- Social media communications via Facebook, Instagram, etc. have been improved and we already note increased activity on these platforms.
- Several other projects were noted and presented.

9. Nominating committee report

Mrs. Gisèle Lacasse Benoit presents the nominating committee's recommendation for the 2022-2023 board of directors. One board member, Mr. Louis Cyr, will be leaving us.
